ADMISSION NOTICE: 2026 – 27 (CLASS VI, VII & IX)

(2nd Phase)

1. Registration Forms for New Admissions for the session 2026-27 in classes VI, VII & IX will be available from **5th March 2026 to 1st April 2026**. Interested candidate should apply online mode only through school's website within the specific date mentioned as above.
2. **Admission test (offline) shall be conducted for admission in class VI, VII & IX on 4th April 2026 (Saturday) at 0900 hours in the subjects of English, Hindi, Mathematics, Science & EVS/Social Science in the school. The merit list will be published on 7th April 2026. Seats will be allotted to all BSF wards (other than BSF Primary School) who qualify in the admission test and to non BSF wards on merit (other than BSF Primary School) depending upon the vacancy position.**
3. **The minimum and maximum age limit for admission in class VI, VII & IX is given below:**

Class	Minimum age as on 31 st March of year in which admission is sought	Maximum age on 31 st March of the year in which admission is sought
VI	10 years	12 Years
VII	11 years	13 years
IX	13 years	15 years

4. **Eligibility for admission in class IX:** The candidate must have passed class VIII exam **including a 3rd language** from an institution affiliated to the CBSE or to any recognized Board or recognized by the Education Department of the State Govt. / U.T. in which such an institution is located.
5. **Admission in classes X & XII:** As per CBSE no direct admission shall be granted in Board Class (X & XII). However, transfer case of BSF ward will be treated as per CBSE directions & as per the situation.

ADMISSION NOTICE: 2026 - 27 (CLASS – XI)

Registration Forms for **Provisional Admission** to class XI for the session 2026-27 in Humanities (Arts), Commerce & Science streams will be available from **27-01-2026 to 27-03-2026**. Interested candidates (Indian National) should apply online through school's website within the specified date mentioned above.

2. The '**PROVISIONAL ADMISSION**' will be granted on merit basis as per class-X Pre-Board Result and subject to '**modification / cancellation**' if found ineligible at later stage on declaration of board result.
3. For obtaining Science stream, a candidate must have studied the following five subjects in class X i.e. English, 2nd Language, Science, Social Science & Mathematics. Only completely pass cases will be eligible to apply under this provision.
4. Students who cannot apply at this juncture due to certain reasons as well as those who have failed to qualify in the Pre-Board examination but qualified in the board examination can apply later, after declaration of Board Result for which '**FRESH NOTIFICATION**' will be issued. Their cases will be considered on merit as per the admission criteria and availability of seats. **The candidates must upload the legible copy of class X Pre-Board Mark sheet. Both BSF wards and BSF school non BSF wards** are being encouraged to take advantage of provisional admission if they have qualified the Pre-Board Exam. A copy of the criteria for admission as approved by the Force Headquarter, BSF New Delhi is displayed for information of all the concerned. **Merit List shall be published on the school notice board as well as in school's website on 10-04-2026 AN.**
5. Merit List will be prepared for Non BSF candidates who have passed out from Non BSF Schools strictly on merit basis as well as vacancy position. Vacancy will be drawn after deducting BSF/Ex-BSF/BSF Widow wards, Staff wards, BSF School Civil Student's admission only.
6. Suitable admission test may be conducted for Non CBSE Board students, if required.
